Sir:

With reference to your application on the subject cited above, I am directed to convey the approval of appropriate authority for upgradation of your school from Middle to Secondary level without aid with effect from the academic session 1998-99 subject to the fulfilments of the following terms and conditions:

1. That the school shall abide by the provision of Delhi School Education Act, 1973 and rules framed thereunder as well as the instructions issued from time to time.
2. That the School shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of Secondary/Senior Secondary classes.
4. That the school shall purchase adequate science Lab. equipments and apparatus as per the norms of C.B.S.E./ Education Department for Secondary/Senior Secondary classes.
5. That a proper Library shall be established and facilities for reading room shall also be made available for students.

as well as teachers. Books as per the ratio of 10 books per students shall be purchased and made available to the students.

- 6. That adequate sports material shall be purchased and made available to the students.
- 7. That the school shall strictly abide by the provisions of Section 10(1) of the Delhi School Education Act/ Rules, 1973.
- 8. That the School shall not run any ~~non-educational~~ classes of any non-educational activities within the school premises and all the ~~recreational~~ classes shall be run at any place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
- 9. That the school shall dispense with the services of unqualified and over-aged staff, if any immediately.
- 10. Fresh Health Certificate from M.C.D. be obtained and produce to Education Officer for verification.
- 11. The Management of the School will obtain land from D.D.A., if already not obtained, in the name of the Society through Directorate of Education, Delhi and shall construct a school building thereon for the school as per specifications of the Department within a period of 2 years. That adequate and sufficient accommodation of 10 sq.ft. per students shall be provided for class-room. The normal size of the class room will 15'x 20'.
- 12. That proper facilities for drinking water, toilet and first-aid be provided. Separate toilets for boys, girls and separate toilets for ladies and gents staff be also provided.
- 13. That the Managing Committee of the school shall not increase ~~school~~ fee during the ongoing academic session without prior approval of the Director of Education which is a mandatory requirement under sub-section (3) of Section 17 of Delhi School Education Act & Rules, 1973.
- 14. That all the facilities prescribed under Rules 50 & 51 of the D.S.E.R. 1973 shall be made available to the students.
- 15. That Xth class should not be added without the prior approval of the Director of Education.

- 16. That the Management of the School shall create a Reserve Fund equal to minimum three month salary of the staff in the joint name of the Director of Education and the Manager of the School.
- 17. That the school shall comply with the norms of the C.B.S.E for affiliation fees/examination purposes.
- 18. That report about the fulfilments of the above conditions shall be sent to the Education Officer within six months.


Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the provisional up-gradation of the existing school to Sr. Sec. School without aid in Commerce & Humanities w.e.f. academic session 2008 - 09 subject to the following terms and conditions:

1. That the school shall abide by the provision of Delhi School Education Act, 1973, and Rules framed there under as well as the instructions issued from time to time.
2. That the school shall meet the additional liability of senior secondary classes.
3. That the school shall admit students without any discrimination of caste and creed.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as for teachers. Books as per the ration of 10 books per students shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of section 10(1) of the Delhi School Education Act / Rules 1973.
7. That the school shall not run any un-authorized classes or any non-educational activities within the school premises and all the recognized classes shall be run at any place at the above address only.
8. That the school shall dispense the services of unqualified and over-aged staff, if any immediately.
9. That Management of the school will obtain land from the DDA, if already not obtained, in the name of the society through Director of Education, Delhi and shall construct a school building thereon for the school as per specification of the Department within the period of three years. That adequate and sufficient accommodation of 10 Sq.ft. per students shall be provided for classroom.
10. The Management committee shall regulate the functioning of school strictly in accordance with the provisions of DSER, 1973.
11. The Managing Committee of the school shall not increase the tuition fees & other charge in future during the academic session without prior approval of Director of Education which is a mandatory requirement under sub-section (3) of Section 17 of Delhi School Education Act & Rules.

12. That all the facilities prescribed under Rule 50 & 51 of the DSEA and Rules, 1973 shall be made available to the students.
13. That the management of the school shall create a Reserve Fund equal to minimum three months salary of the staff in the joint name of Director of Education and Manager of the School.
14. That the school shall comply with the norms of the CBSE for affiliation fees / examination purpose.
15. That school should admit students under EWS quota as per direction issued by the department.
16. That the school authority will maintain the depreciation reserve fund and will deposit the amount collected as development fund since the recognition of school and the same should be reflected in the financial statement of the year 2008-09
17. **That the school authority will submit the experience certificate of the Manager of the school duly attested by a gazetted officer and duly countersigned by the EO/DEO of the concerned zone within a month.**
18. **That the school authority will submit the Building Completion Certificate and up to date Health Certificate from the local competent authority by 31/03/2009, failing which the upgradation of the school would lapse.**


